

APPLICATION

TAKE NOTICE THAT the applicant, Bayer Inc., will make an application for judicial review under section 44 of the *Access to Information Act* (the "Act") in respect of the decision of the Minister of Health, by his delegate, dated November 25, 2021 and bearing file number A-2018-001052 / MR1, to disclose third party information belonging to the applicant (the "Confidential Information") contained in a particular record, pursuant to a request under the Act, in Toronto on a day and time to be set by the Court.

THE APPLICANT MAKES APPLICATION FOR:

- (a) a declaration that the Minister of Health erred and/or acted contrary to law by deciding to disclose the Confidential Information;
- (b) an order pursuant to section 51 of the Act prohibiting the Minister from disclosing the Confidential Information;
- (c) an interim order under s. 18.2 of the *Federal Courts Act* and Rule 151 of the *Federal Courts Rules* preserving the confidentiality of the Confidential Information in this proceeding;
- (d) an order granting the applicant its costs of this application; and
- (e) such further and other relief as to this Honourable Court may seem just.

THE GROUNDS FOR THE APPLICATION ARE:

1. The Minister committed a reviewable error in deciding to disclose the Confidential Information even though it contains financial, commercial, scientific or technical information that is confidential information supplied to the Minister by the applicant and is treated consistently in a confidential manner by the applicant.

- 2. The Minister committed a reviewable error in deciding to disclose the Confidential Information even though it contains information the disclosure of which could reasonably be expected to result in material financial loss or gain to, or could reasonably be expected to prejudice, the competitive position of the applicant.
- 3. Sections 2, 3, 6, 20, 24, 25, 27, 28, 41 to 51, 53 and 62 of the *Act*.
- 4. The Federal Courts Act and Federal Courts Rules, including rules 151 and 152.
- 5. Such other grounds as counsel may advise and this Honourable Court may permit.

THIS APPLICATION WILL BE SUPPORTED BY THE FOLLOWING MATERIAL:
