This says to me that the letter was automatically generated and not subject to any external oversight, such as CRA personnel doing any reviews of the document submissions.

If the February 15 letter was automatically generated, then there was no physical review of the submitted documents at the time of the letter being sent. I can not be

held liable for the lack of review of submitted documents by the CRA, as they are out of my ability to influence once submitted. As the requested documents had been submitted before the letter's date, they should be seen as having been submitted in good faith, as requested by the CRA Agent I had been in contact with (Nathan, Badge #38819) despite not having been yet reviewed.
