This is an application for judicial review in respect of

The decision of Sandra Pion, Canada Revenue Agency Team Leader Taxpayer Relief Centre of Expertise, dated April 25, 2022 but not received until May 11, 2022. The applicant Sasm Hajar of Hajar Properties Inc. reference number GB2208-7141-3172 account number 85631-7383-RC0001

The applicant makes application for:

1. A review by the federal court regarding the Canada Revenue Agency's decision not to refund the interest and penalties paid in the amount of \$8,783.14
2. Cost of this application
3. Such further and other relief as the Applicant may request and this Honourable Court may deem just.

The grounds for the application are:

1. The decision of this matter was unreasonable;
