

APPEAL

THE APPELLANT APPEALS to the Federal Court of Appeal from the decision of Justice S. Fothergill dated June 29, 2022 (the "Judgment") which dismissed the application of Appellant to restrict the release of certain materials under the *Access to Information Act*, R.S.C. 1985, c. A-1, as amended (the "Act").

THE APPELLANT ASKS that:

- 1. this appeal be allowed and the Judgment be set aside;
- an Order be made that the Contentious Documents (defined below) are exempt from disclosure pursuant to section 20(1) of the Act;
- such incidental Orders or Directions be made so as to preserve the confidentiality of the record in this appeal and of the Application (defined below) until the final determination of this appeal;
- 4. the Appellant be awarded its costs of this appeal and the Application below as against the Respondent, the Minister of Health; and
- 5. this Court grant such further and other relief as deemed just.

THE GROUNDS OF APPEAL are as follows:

6. The appealed-from application, Federal Court proceeding T-6-20, was an application by the Applicant, Actial Farmaceutica s.r.l, now the Appellant, to prevent the release of certain additional documents to the original Access to Information requestor (the identity of which is not known with certainty by the Appellant) pursuant to Health Canada's Access to Information and Privacy Division file A-2018-001128/NK, as in the view of

- the Appellant the Contentious Documents were properly exempt from disclosure under the exemptions provided in the Act (the "Application").
- 7. In the course of the Application, the parties agreed regarding the vast majority of redactions already made to the records proposed for disclosure by the Access to Information and Privacy Division of Health Canada. The trial judge maintained these redactions.
- 8. The *lys* of the dispute in the Application turned on whether two particular documents should, in addition, be exempt from disclosure under the Act. These are referred to herein as the "Contentious Documents."

First Ground – The Appellant is Property a "Third Party" under the Act

9. The trial judge erred in fact and in law in determining that the Appellant (Applicant below) was not a "third person" for the purposes of the Act, and therefore not entitled to bring the proceeding.

Second Ground – The Contentious Documents are Exempt from Disclosure

- 10. The trial judge erred in law and in fact in determining that the Appellant did not meet the burden of demonstrating that the Contentious Documents were exempt from disclosure *in toto* under the exemptions from disclosure for certain third-party materials permitted by section 20(1) of the Act.
- 11. In particular, the trial judge erred in fact and in law by relying at least in part on evidence that some of the content of the Contentious Documents was publicly available. In doing so, he misapprehended the import of statements by the Appellants' competitors and disaffected former officers, which are not be taken as true statements of actual

"information" that is publicly available.

12. Further, although the trial judge correctly held that the burden of showing that any given information is exempt from disclosure must be born by the applicant, he erred in law by incorrectly applying too high a standard for the threshold that must be met by such an applicant to show that the information meets the exemptions.

 - (a) The Access to Information Act, R.S.C. 1985, c. A-1, as amended;
 - (b) The record of the Application below; and
 - (c) Such other provisions as counsel may advise and the Court of Appeal accept.
