This is an application for judicial review in respect of

This is an application for Judicial review in respect of the decision of the Canada Revenue Agency, which was communicated to the applicant by letter dated March 10, 2023 (Attachment #1). The decision of the CRA was received by the applicant on April 3, 2023. By its decision, the CRA decided the applicant was not eligible for Canada Recovery Benefit (CRB) for the year 2020 based on not meeting the criteria of having to earn at least \$5000 that year. Applicant provided proof of earning of over \$5000 in the year 2020 and 2021 (attachment #2 and Attachment #3) The applicant received a letter dated March 14, 2023 (Attachment #4) which turned down the proof provided and was said to have a balance due of \$16 000.

I am making this application to prove and submit documentation that I am eligible to receive the Canada Recovery Benefit. All of the requisite information previously provided to CRA to determine my eligibility will be provided.


