## APPEAL

THE APPELLANT APPEALS to the Federal Court of Appeal from the order dated June 29, 2022 of the Honourable Justice Patrick Boyle of the Tax Court of Canada (the "TCC") by which the Appellant's appeal from the reassessment (the "Reassessment") made on September 14, 2017 under the *Income Tax Act* (Canada) (the "Act") for its 2013 taxation year was dismissed, with costs, 2022 TCC 71.

THE APPELLANT ASKS that the appeal be allowed and the Reassessment be referred back to the Minister of National Revenue for reconsideration and reassessment on the basis that its loss of \$1,181,273 arising from the sale of its shares of Lincoln Mining Corporation and its loss of \$904,645 arising from the sale of its shares of Chieftain Metals Inc. were on income account rather than on capital account, with costs here and below.

THE GROUNDS OF APPEAL are as follows: Justice Boyle erred in law in failing to (a) identify the correct legal tests for determining inventory versus capital property and (b) apply those tests to the facts.

The Appellant requests the TCC to send a certified copy of the following material that is not in the possession of the Appellant but is in the possession of the TCC to the Appellant and to the Registry: all Exhibits filed at the hearing of the TCC appeal and a transcript of all Discovery questions read in or copies of all Discovery questions handed up.
