This is an application for Judicial review in respect of
Canada Revenue Agency, Assessment, Benefit and Services Branch.
Canada Recovery Benefit eligibility and Employment Insurance Benefit
Of March 24, 2023, communicated on April 3, 2023.

Re: Second review for Canada Recovery Benefits application:

Since you are not allowed to receive a payment from both Service Canada and the CRA for the same weeks, you must repay the amount of \$3,000 the CRA issued to you.

The applicant makes application for: the allowing of EI benefits and CERB.

The grounds for the application are:

1. I am a self-employed counsellor offering in person counselling services through a registered sole proprietorship "Victory Counselling" after completing employment with Hospice Palliative Care Association of PEI in November 2019.
2. As a result of federally mandated and provincially enforced health protocols commencing in March 2020, my business was effectively forced to close, leaving me with no employment income.
3. As a result of widely publicised relief offers of Canada Emergency Response Benefits (CERB), and after speaking with various federal government employees regarding my eligibility, I made application for CERB, having been fully assured that I was acting in compliance with the guidelines for CERB and Employment Insurance (EI) benefits.
4. At no time was I informed that my collecting CERB and EI benefits for a period of six weeks (March 29, 2020, to May 9, 2020) was in contravention of any rules, regulations, legislation or policy.
5. A letter of 7 October 2020 from the Montague, PEI scc was provided indicating that if it was to my advantage, it had delayed the start of my EI benefits starting October 4, 2020.

6. A review of all CRA correspondence from 5 August 2020 to 23 March 2023 was silent as to any wrongdoing on my part despite having filed the required income tax returns for 2020 and 2021.
7. It is my sincere belief that I always acted in accordance with directions received from employees of Service Canada, either by telephone or in person at the Montague PEI Service Canada Centre.
