This is an application for judicial review in respect of CRA. The applicant applied for the CRB in July 2021. The applicant was told by the CRA agent that they were eligible for the benefit they applied for listed above. However, after the applicant received all the money and benefits from CRA, the applicant was told that they were not eligible and their final decision was sent on April 12, 2023, after a second review was requested by the applicant on March 17, 2022. The review was done by Constantin, a Canada Emergency Benefits Validation manager.

The applicant makes an application for:


1. Calling off the payments wanted by CRA for the benefits the applicant applied for

1. An order, pursuant to section 18.1 paragraph 4(b) of the federal act declaring that the tribunal failed to observe a principle of natural justice and procedural fairness that was required by law to observe since the government employees indicated false information towards the applicant and therefore, the applicant shouldn't be liable for their mistake
