

### **Application**

#### Judicial review of CERB/CRB decisions

#### This is an application for judicial review in respect of

Canada Revenue Agency

On May 15/2023 the CRA advised me that I was not eligible for the CERB and CRB benefit because I did not meet the following criteria:

- A) For the CRB benefit you did not have a 50% reduction in your average weekly income compared to the previous year due to COVID-19.
- B) For the CERB benefit you did not stop working or have your hours reduced for reasons related to COVID-19.

#### The applicant makes application for:

To be absolved of these debts owed to the CRA,

\$18,000 for the CRB benefit and \$8000 for the CERB benefit, because it will create undue hardship.

#### The grounds for the application are:

In 2020 I had two business endeavours on the go.

The 1st was day trading on the TSX and the DOW JONES.

The 2<sup>nd</sup> was my Handyman venture (Cyril's Toolbox) which is a part time endeavour.

A) When COVID-19 became official on March 18<sup>th</sup> the DOW JONES dropped 34% to below 19,000 points and took months to recover. The stocks I had invested in dropped dramatically in value. I have submitted to the CRA the evidence of my over 50% reduction of my weekly income compared to the previous year. EXHIBIT "A".

B) In regards to my Handyman services, when COVID-19 hit it seemed like someone turned off the taps, there were literally no calls for service. The few calls I received were difficult to pursue because no one wanted anybody on their property, so I basically stopped working.


