

APPLICATION

THIS IS AN APPLICATION FOR judicial review in respect of a decision (the "Decision") of the Transportation Appeal Tribunal of Canada (the "Tribunal") dated on or about April 11, 2023, denying the Applicant's appeal and upholding the review determination.

The Tribunal delivered the Decision to the Applicant on April 11, 2023.

THE APPLICANT MAKES APPLICATION pursuant to Section 18.1 of the Federal Courts Act for:

- a) A declaration that the Tribunal erred in law when it failed to apply the *Canadian Human Rights Act* and consider the Minister of Transport's duty to accommodate to the point of due hardship under subsection 15(2);
- b) An order that the Minister of Transport issue a Master Mariners' Certificate to the Applicant;
- c) In the alternative, an order setting aside the Tribunal's April 11, 2023 Decision and referring the matter back to the Tribunal for a determination in accordance with the directions of this Honourable Court;
- d) An order awarding costs to the Applicant for this application; and
- e) Such further and other relief as may be requested by the Applicant and considered appropriate by this Honourable Court.

THE GROUNDS FOR THE APPLICATION ARE:

- 1. The Tribunal erred in law when it failed to apply the *Canadian Human Rights Act* by failing to consider whether the Minister of Transport had accommodated Mr. Adams' medical restrictions to the point of undue hardship;
- 2. Section 278(5) of the Marine Personnel Regulations, SOR/2007-115 adopted under the Canada Shipping Act, 2001, S.C. 2001, c. 26, states that the Minister of Transport's decision with regard to any medical certificate shall be based on several criteria, including any relevant consideration linked to human rights as set out in the Canadian Charter of Rights and Freedoms;
- 3. Such further and other grounds as the applicant may raise and this Honourable Court may allow.

THIS APPLICATION WILL BE SUPPORTED BY THE FOLLOWING MATERIAL:

- a) The record of the proceedings before the Tribunal;
- b) The Applicant's Affidavit and such other affidavits as are necessary;
- c) The Application Record.

THE APPLICANT REQUESTS pursuant to Rule 317 of the *Federal Court Rules*, that the Transportation Appeal Tribunal of Canada send a certified copy of the following material that is not in the possession of the applicant but is in the possession of the Tribunal to the applicant and to the Registry:

1. The full record of all materials, including transcripts of the hearing and all exhibits, which were before the Tribunal at the time it rendered its Decision.
