APPEAL

THE APPELLANT APPEALS to the Federal Court of Appeal from the order Justice Go issued on 4 February 2022 in **T-650-21** by which the Court ordered that:

1. The application for judicial review is dismissed.
2. The Style of Cause will be amended to reflect the Attorney General of Canada as the Respondent.
3. There is no order as to costs.


THE APPELLANT ASKS that

1. Justice Go's February 4th be quashed;
2. the Court declare that "judicial conduct" includes judicial decision-making;
3. the Court declare that the exclusion from review of "decisions" only applies to rulings which may be appealed but have not yet been appealed;
4. the Court declare that the Canadian Judicial Council may not refuse to investigate complaints from those who were wrongly convicted;
5. the Court declare that ¶¶22-24 of *Canada (M.C.I.) v. Fisher-Tennant*, 2018 FCA 132, is binding on Federal Court jurists;
6. the Canadian Judicial Council be ordered to pursue my complaint against the jurist who convicted me of a crime that did not occur and those who allowed Justice Creigh's unlawful conviction to stand; and
7. any additional relief favourable to the appellant.

THE GROUNDS OF APPEAL are as follows:

1. s. 63 of the *Judges Act* does not exclude "decisions" from what the Canadian Judicial Council shall review when complainant alleges that a judge "has threatened the integrity of the judiciary as a whole;"
2. "judicial conduct" includes judicial decision-making;
3. the only judicial decisions the Supreme Court of Canada in *Moreau-Bérubé*, 2002 SCC 11, held the CJC shall not investigate are those which may be, but have not yet been, appealed;
4. Federal Court jurists are obliged to follow FCA rulings, including ¶¶22-24 of *Fisher-Tennant*, 2018 FCA 132; and
5. such additional grounds as the appellant should advance.
