Application

This is an application for judicial review in respect of the decision of Health and Safety Officer, Tara Withers, Official Delegated by the Head of Compliance and Enforcement, Employment and Social Development Canada, dated February 15, 2023 (the “Decision”). The Decision set out that the Head would not investigate the Applicant’s work refusal pursuant to s. 129(1)(a) of the *Canada Labour Code*, RSC 1985, c L-2 (the “Code”).

The Applicant makes application for:

1. An order in the nature of *certiorari*, quashing the Decision dated February 15, 2023;
2. An order in the nature of *mandamus*, directing the Head to investigate the Applicant’s work refusal;
3. An order granting the applicant her costs of the application; and
4. Such other order as this Honourable Court deems appropriate.

The grounds for the application are:

1. The February 15, 2023 Decision was unreasonable in holding that Ms. Goldberg’s matter would be more appropriately dealt with under the *Canadian Human Rights Act*. Ms. Goldberg initiated a work refusal because she experiences episodes of blindness from the use of her computer. This constitutes a danger within the meaning of the *Code*. The Decision has denied Ms. Goldberg access to an investigation pursuant to the *Code*. It is unreasonable to exclude Ms. Goldberg from the processes available under the *Code* to determine whether there is a danger in the workplace simply because she is *also* entitled to accommodations for her disability.

This application will be supported by the following material:

2. The record of proceedings.
