Application

This is an application for judicial review in respect of

The Canada Revenue Agency decision dated June 1, 2022, and communicated to the applicant on June 1, 2022, issued by Donna Boivin, Manager at Canada Emergency Benefits Validation denying eligibility of Mashael Zidan for CRCB benefits and referenced C0043278394-001-45.

The applicant makes application for: reconsidering the decision and granting eligibility for CRB to Mashael Zidan.

The grounds for the application are:

- The CRA has based its decision on an erroneous finding of fact that appears to have been made without regard for the material submitted by Mashael Zidan (the applicant).
- There was no communication between the officer and the applicant between submitting the documents and issuing the decision.
- To clear the misunderstanding, the applicant attempted to contact the 2nd review officer, but there was no answer.
