

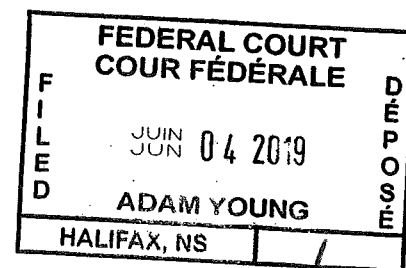

APPLICATION

This is an application for judicial review in respect of a decision of the Canada Revenue Agency, ("CRA"), Taxpayer Relief Centre of Expertise, Appeals Branch, communicated by letter dated April 30, 2019 addressed to the attention of Stephen Burk, (sic "Burke"), president of the applicant. The decision was received by the applicant on May 7, 2019. The decision communicated was a refusal from failure to file penalty, repeated failure to file penalty, failure to file electronically and arrears interest to exercise CRA's discretion in favour of the applicant.

The applicant hereby applies for an order that the said decision be set aside and that the matter be returned to CRA for reconsideration by a different decision maker.

The grounds for the application are:

- a. The CRA officer unreasonably refused to exercise his discretion to exercise his jurisdiction to grant the requested relief in a fair and reasonable manner;
- b. The CRA officer failed to observe the principles of natural justice, procedural fairness or other procedures he was required by law to observe;
- c. The CRA officer misapprehended the relevant facts supporting the request for relief;
- d. The CRA officer conducted a very cursory review of the taxpayer's financial information and made little attempt to understand the true extent of the taxpayer's available cash flow;
- e. The CRA officer painted an inaccurate picture of the taxpayer's financial situation,
- f. The CRA officer's conclusions in the report regarding the taxpayer's ability to borrow money are unjustified.

This application will be supported by the following material:

- a. Affidavit of or on behalf of the applicant; and
- b. Such other material this Honourable Court may permit.

The applicant requests the CRA to send a certified copy of the following material that is not in the possession of the applicant but is in the possession of the (tribunal) to the applicant and to the Registry:

All documentation that relates to the decision for which judicial review is hereby sought, together with notice and explanation as to such documentation, if any, that the Respondent declines to so send.


