<u>APPLICATION</u>

This is an application for judicial review in respect of a decision dated December 21, 2022 and received on January 6, 2023 issued by the Canadian Human Rights Commission (the "Commission") deciding not to deal with the applicant's complaint pursuant to section 41(1)(d) of the Canadian Human Rights Act, R.S.C., 1985, c. H-6.

- 1. The applicant makes application for:
 - a. an Order that the decision of the Commission dated December21, 2022 be quashed (the "Decision");
 - b. the costs of this Application; and
 - such further and other relief as may be required and this
 Honourable Court may deem just in the circumstances of this case.
- 2. The grounds for the application are:
 - a. the Federal Courts Act, R.S.C., 1985, c. F-7 ("Federal Courts Act"), as amended, and in particular sections 18 and 18.1;
 - b. the Canadian Human Rights Act, R.S.C., 1985, c. H-6, as amended;
 - c. the Commission is a federal board, commission or other tribunal pursuant to the *Federal Courts Act*;

- d. the applicant filed a complaint with the Commission and against the National Research Council of Canada for discrimination on the basis of disability in the provision of services;
- e. in the Decision, "the Commission decides, pursuant to paragraph 41(1)(d) of the Canadian Human Rights Act ("Act"), not to deal with the complaint because the National Building Code is not a "service" within the meaning of the Act and therefore a case of discrimination within the meaning of the Act cannot be established."
- f. the applicant says that the Decision is unreasonable because the reasons for the Decision state a conclusion, and do not meet the requisite standard of justification, transparency, and intelligibility.
- 3. This application will be supported by the following material:
 - a. the affidavit of Elizabeth Portman, to be filed; and
 - b. such further and other documentary evidence as counsel may provide and this Honourable Court may allow.
