## APPEAL

THE APPELLANT APPEALS to the Federal Court of Appeal from the interlocutory order of the Honourable Don R. Sommerfeldt of the Tax Court of Canada (the **Motion Judge**) dated August 10, 2023 (the **Order**) in Tax Court of Canada Appeal Number 2016-3653(IT)G (the **Tax Court Appeal**) by which the Motion Judge, among other things:

1. Denied the Appellant's request to compel responses to disputed discovery questions 2, 3, 4, 5, 6, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 20, 21, 22, 23, 25, 27, 29, 30, 32, 33, 35, 36, 37, 38 and 39 (the **Disputed Questions**), on the basis that the Respondent had not waived existing solicitor-client privilege over the information sought; and
2. Found that costs of the motion would be in the cause unless otherwise determined by the trial judge.

THE APPELLANT ASKS that the appeal be allowed with costs here and below and that the Order be set aside, with this Court granting the order that should have been given.

THE GROUNDS OF APPEAL are as follows:

1. The Motion Judge denied the Appellant procedural fairness and made a reviewable error by failing to consider an issue raised by the Appellant in its motion, namely, whether the information sought by the Disputed Questions was subject to solicitor-client privilege;
2. The Motion Judge made a reviewable error by finding that the Disputed Questions did not need to be answered because they sought information that was subject to solicitor-client privilege;

3. In the alternative, if the information sought by the Disputed Questions was privileged, the Motion Judge made a reviewable error by concluding that the Appellant did not put its state of mind at issue in the appeal and therefore did not implicitly waive privilege; and
4. Such further and other grounds as counsel may advise and this Honourable Court may allow.
