

APPLICATION

THIS IS AN APPLICATION under s. 38.04(1) of the Canada Evidence Act RSC, 1985, c C-5 (CEA), for an order regarding disclosure of information referred to in a Notice under s. 38.01(1) of the CEA that was provided to the Attorney General of Canada (AGC) on February 19, 2024. In the notice, counsel for the Public Prosecution Service of Canada advised that they are required to disclose sensitive or potentially injurious information in criminal proceedings against Matthew Althorpe and Kristoffer Nippak before the Ontario Court of Justice (Court File No: 4810-998-23-48120168) (the Underlying Proceeding).

THE APPLICANT MAKES APPLICATION FOR:

- (a) An order under s. 38.06(3) of the *CEA* confirming the prohibition of disclosure of the information referred to in the notice, except as previously authorized by the AGC under s. 38.03(1) of the *CEA*;
- (b) An order authorizing the disclosure of a summary of the information or written admission of facts relating to the information; and
- (c) Such further and other relief as the Applicant may request and the Court deems just.

THE GROUNDS FOR THE APPLICATION ARE:

- (a) On December 5, 2023 charges were laid against Mr. Matthew Althrope and Mr. Kristoffer Nippak pursuant to s. 83.18(1) of the Criminal Code. Mr. Althorpe was further charged pursuant to ss. 83.19(1), 83.2, 83.22 and 83.221 of the Criminal Code.
- (b) On February 19, 2024, counsel for the Public Prosecution Service of Canada provided notice to the AGC pursuant to s. 38.01(1) of the CEA, stating that they believed that sensitive or potentially injurious information may be disclosed in connection with the criminal proceedings against Mr. Althorpe and Mr. Nippak. The Notice is with respect to 22 documents;

- (c) On February 19, 2024, the AGC authorized disclosure of the fact that notice had been given;
- (d) On February 22, 2024, the AGC, through his delegate, did not authorize the disclosure of information contained in all 22 documents that were subject of the Notice;
- (e) Disclosure of the information in question would be injurious to national security and national defence;
- (f) The public interest in non-disclosure outweighs the public interest in the disclosure;
- (g) The AGC may receive future notices pursuant to s. 38 of the *CEA* covering additional documents in connection with the Underlying Proceeding that will become part of this application; and
- (h) Further and other grounds as the Applicant may advise and this Honourable Court may permit.

THE ATTORNEY GENERAL MAKES THE FOLLOWING REPRESENTATIONS UNDER SECTION 38.04(5) OF THE CEA:

- (a) Mr. Matthew Althorpe, Mr. Kristoffer Nippak and the Director of Public Prosecutions are parties whose interests are affected by the information contained in the documents subject to these proceedings and must be named as Respondents;
- (b) A copy of the Notice of Application, amended to include Mr. Althorpe, Mr. Nippak and the Director of Public Prosecutions as the Respondents, should be served on Mr. Althorpe and Mr. Nippak, or their respective counsel, and the Director of Public Prosecutions;

- (c) The Notice of Application must remain confidential until it is amended to name Mr. Althorpe, Mr. Nippak and the Director of Public Prosecutions;
- (d) A hearing under paragraphs 38.04(5)(a) or (a.2) of the CEA is not required;
- (e) A public hearing may be necessary;
- (f) An ex parte, in camera hearing will be necessary;
- (g) This application should be conducted as a specially managed proceeding; and
- (h) Further grounds as the Applicant may advise and this Honourable Court may permit.

THE APPLICATION WILL BE SUPPORTED BY THE FOLLOWING MATERIAL:

(a) The amended Notice of Application; and

(b) Affidavits and other material as counsel may advise and this Honourable Court may permit.
