Canada Recovery Benefits eligibility validation review of Marina Komleva's application.

July 16, 2021

Re: Second review for Canada Recovery Benefits application.

- You did not earn at least \$5,000 (before taxes) of employment or net self-employment income in 2019, 2020, or in the 12 months before the date of your first application.

The applicant makes application for:

CRA to accept factual evidence of Marina Komleva income from February 2020 to end of March 2020/beginning of April 2020.

The grounds for the application are:

- 1. Starting from the beginning of January 2020, Marina Komleva was helping her husband, Jakov Bassel, to do his work as an architectural visualization and drafting technician under his supervision, due to his illness.**
- 2. The work was negotiated with the clients by Jakov Bassel and the money for Marina Komleva's work was paid as per Jakov Bassel's invoices to the clients, and was coming to their joint account in the bank through online payments.**
- 3. From February 2020 and to the end of March 2020, Marina Komleva had to fully replace Jakov Bassel in his task due to his two surgeries and subsequent recovery periods, and therefore his inability to physically do his usual work, with the nature of the work that requires prolonged sitting in front of the computer.**
- 4. Doctor's operative reports are included with this Application to confirm that Jakov Bassel underwent two surgeries: the first on February 4, 2020, following by the second on February 27, 2020.**
- 5. Also included in this Application bank statements confirming the work income for that period of time.**
- 6. Both facts: Jakov Bassel's illness and proven income are the evident that Marina Komleva was the only person, who earned the money in the given period of time.**
