1. This is an Application for Judicial Review sought by Alex Martinez on his own behalf and on behalf of Section(s) 300(a)(b)(c)(d)(e)(f)(g)(h) of the Federal Court of Canada Rules & Section 18.1(1) of the Federal Courts of Canada Act.

The grounds for the application are:

2. This is an Application for a Judicial Review in regards to the July 3<sup>rd</sup>, 2020 and July 30<sup>th</sup>, 2020; Decisions by the Social Security Tribunal of Canada; for the Appeal and Application for Leave to Appeal for the Decisions of the Canada Employment Insurance Commission.


- 3. The Application is being made for errors and non-compliance with the Social Security Tribunal Regulations, SOR/2013-60; as they did not exercise discretion properly as the case warrants further consideration; based on its merits.
- 4. The decisions made by all the Divisions of the Social Security Tribunal of Canada Divisions were made in haste and in 'error of Jurisdiction' as they did not exercise their powers of discretion to property adjudicate this case. This is supported by the Employment Insurance Act; S.C. 1996, c. 23, for there are no provisions that limit their powers to preside; or, exercise discretion in this case.
- 5.
