APPLICATION

I. THIS IS THE APPLICATION FOR A JUDICIAL REVIEW OF:

1. The written decision of the Canadian Human Rights Commission stamp dated April 13, 2023 (herein "the decision") denying the complaint 20170602, of Arif Hussain, the Applicant. The decision was sent to the applicant on May 10, 2023.

II. THE APPLICANT MAKES APPLICATION FOR:

2. A Declaratory Order quashing the decision of the Canadian Human Rights Commission to deny the complaint of the Applicant.
3. Declaratory relief that the decision of the Canadian Human Rights Commission is invalid or unlawful.
4. Such further and other relief as this case may require and the Court may permit.

III. GROUNDS FOR THE APPLICATION ARE:

5. The Commission failed, properly or at all to consider, and if they did consider, failed to properly apply Section 41 of the Canadian Human Rights Act.
6. The Commission acted without jurisdiction, acted beyond their jurisdiction or refused to exercise their jurisdiction.
7. The Commission failed to observe the principles of natural justice, procedural fairness or the procedures that the Commission was required by law and Act to observe.
8. Such other grounds as may be available.
