NOTICE OF APPLICATION

APPLICATION UNDER section 18 and 18.1 of the Federal Courts Act

On August 30, 2023 I got a "Second review letter – no adjustment" from S.Constantine, Manager Canada Emergency Benefits Validation regarding my CWLB eligibility that said I was not eligible to CWLB benefits as I did not meet the criteria that I did not earn at least \$5000 (before taxes) of employment and/or net self-employment income in 2020, 2021, or in the 12 months before the date of my application, and the region where I live, work, or provide a service was not designated as a Covid-19 lockdown region. It was also said that if I disagree with the result of the second review, I may apply to the Federal Court for a judicial review within 30 days of the date of this letter.

TO THE RESPONDENT:

APPLICATION

This is an application for judicial review pursuant to section 18 and 18.1 of the Federal Courts Act, R.S.C., 1985, c.F-7 in respect of the decision of the Canada Revenue Agency ("CRA") on behalf of the Minister of National Revenue (the "Minister") communicated to the Applicant by a letter dated August 30, 2023, reference number C0056921973-001-45, (the "Decision").

In the Decision, the CRA:

1. Found that the Applicant was ineligible for the Canada Worker Lockdown Benefit (CWLB), pursuant to the *Canada Worker Lockdown Benefits Act*.
2. Denied CWLB benefits pursuant to the finding of ineligibility.

The Applicant makes an application for:

1. an Order setting aside the Decision and referring the matter back to the Minister for reconsideration in accordance with such directions as this Honourable Court considers appropriate;
2. an Order for costs; and
3. such other Order as this Honourable Court deems appropriate and just in the circumstances.

The grounds for the application are:

- a) relied on erroneous findings of fact made in a perverse and capricious manner and/or without regard for the material before her;
- b) rendered a decision that is not within the range of acceptable or defensible outcomes on the facts and the law;
- c) did not answer any phone calls or attempts to supply relevant information, despite multiple calls a month; and
- d) breached her duty of procedural fairness to the Applicant, including by failing to consider the material before her, failing to respond to attempts to contact, failing to communicate, failing to receive information, failing to provide direction as to the material required for consideration, failing to ask for the clarification, failing to provide reasons for decisions in a transparent manner, failing to provide a transparent process for application and request for reconsideration, failing to exercise her discretion impartially, and failing to consider the Applicant's request without undue delay.

This application will be supported by the following materials:

1. Second review letter – no adjustment dated August 30, 2023, reference number: C0056921973-001-45
2. Bank activity from 2021
3. Receipt from my business.

REQUEST FOR MATERIAL PURSUANT TO RULE 317

The Applicant requests that the Respondent provide certified copies of every document in the possession of the CRA that was relied upon by the CRA (including its current or former officers, employees or agents) in making the Decision or that otherwise relates to the Decision, including but not limited to the directives, guidelines, memoranda, briefing notes, file coding screens, working papers, working notes, diary entries, notes of telephone conversations, correspondence, (including internal correspondence and email), reports, and any other documents (including documents in electronic form) prepared by or for, or addressed to, any current or former officer, employee or agent of the CRA.
