Re: Second Review for Canada Recovery Benefits application

You did not have a 50% reduction in average weekly income compared to the previous year due to COVID-19.

The applicant makes application for: Reinstatement of Canada Recovery Benefits eligibility

The grounds for the application are:

- 1. The eligibility criteria under the Canada Recovery Benefits Act in section 3 (1) paragraph (f) states that during the 2 week period for which the application was submitted, the individual was either not employed or self employed OR had a reduction of at least 50% in average weekly employment or self employment income compared to the previous year due to reasons related to COVID-19. Thus, I had to fulfill one of the two criteria in order to be eligible for the CRB. The CRA states that I simply did not satisfy one of the two, however, I was unemployed AND self-employed as a result of lockdown measures during the periods I applied for from December 2020 until August 2021. This is a criteria that the CRA completely ignored.
- 2. During the periods I applied in the months of December 2020 until August 2021, not only was Llet go from Off the Hook (as of December 2020) as a result of the lockdown, but I was also a self-employed worker at Canada College. I took on the job at the college starting October 2020 in the midst of the pandemic in order to better support myself and my family financially during this period of economic shutdown, considering my hours at Off the Hook were significantly reduced.
- 3. After the new year of 2021, I reached out to the administrative assistant at the college in order to follow up regarding the availability of courses that I could teach. However, according to the administrative assistant I did not provide my availabilities (a mistake on their part since my availabilities did not change from the previous session prior to the new year and they were aware of that). I attempted to dispute this with the college since I was certain that I provided my availabilities in a survey they sent out a few months prior, however to no avail. The assistant informed me that there were no available classes for me to teach for the winter 2021 session, which was also as a result of fewer classes being available at the time since each session is different (depending on the volume of students enrolled, teacher availability, and the measures of COVID that were enforced at the time). I was unable to work as a self-employed worker for the months of January 2021 until May 2021.
- 4. I continued to seek work during those months, either through filling in for replacements/substitutions however it was very minimal. I was able to resume my work as a self-employed worker for the summer 2021 session beginning June 2021. I continued to apply for the CRB under the condition that I was a self-

employed worker due to reasons related to COVID-19 (to create more financial stability in my household during the economic shutdown as a result of the pandemic).
